
# Investment Committee Semi-Annual Activity Report

#### CHIEF INVESTMENT OFFICER REPORT

An understanding of global market performance in the current fiscal year and recent 3 year period is helpful context when reviewing semi-annual reports for each asset class. Since CalSTRS has a 30 year investment horizon it is helpful to look at these semi-annual snapshots over multiple time periods to get a sense of the changes over the past five to ten years.




### U.S. Treasury Yield Curve







Asset Allocation

During the July 2023 meeting, the Investment Committee adopted new interim asset allocation targets effective July 1, 2023. These targets included a reduction in Public Equity and an increase in Private Equity. The Investment Committee finished its every-four-years Asset-Liability Management Study in 2023 when it adopted long-term asset allocation targets.








# Non-U.S. Top 10 Net Exposure as of December 31, 2023




Non-U.S. Net Currency Value vs Total as of December 31, 2023
