III. CONSIDERATION OF PROPOSED ADMINISTRATIVE DECISION (Item 3)

a. In the Matter of the Appeal Regarding the Final Compensation Calculation of: Dorothy Cole

The committee received a presentation from Ms. Kaur and Mr. Cozad regarding the proposed decision by the administrative law judge in the matter of *In the Matter of the Appeal Regarding the Final Compensation Calculation of: Dorothy Cole*, which upheld CalSTRS' determination that the longevity pay Dr. Cole received was included erroneously in calculating her retirement benefits. The committee discussed how Dr. Cole's compensation was misreported by the school district and how Dr. Cole was the only psychologist receiving the longevity pay. The committee inquired about whether the longevity pay was creditable compensation, the circumstances surrounding Dr. Cole's settlement with the school district concerning longevity pay, and whether the administrative law judge had a complete record of the documents. The committee learned that staff requested copies of public records from the district that showed that longevity pay was provided to all psychologists, but the district provided no documents in response and Dr. Cole did not present any such documents as evidence at the hearing. Mr. Waddell asked clarifying questions regarding the findings of the administrative law judge.

Although staff disagreed with the proposed decision as to Dr. Cole's employee class and that other psychologists would have received the longevity pay after the 2006-2007 school year if they qualified for it, staff agreed with the conclusion that the longevity pay should not have been included in calculating Dr. Cole's retirement benefit because it did not meet the definition of creditable compensation. Thus, pursuant to Government Code section 11517, subdivision (c)(2)(C), staff recommended that the committee adopt the proposed decision with the following technical or other minor changes:

- 1. On page 2, in the "Issue" statement, change "Lynwood School District" to "Lynwood Unified School District."
- 2. On page 2, paragraph 1, line 2, change "education" to "educators and."
- 3. On page 2, paragraph 1, line 4, change "the inception of retirement" to "their benefit effective date."
- 4. On page 2, paragraph 1, line 5, add "final compensation that must be" before "creditable."
- 5. On page 3, paragraph 5, line 8, change "on" to "effective" and add "and the LTA" after "District."
- 6. On page 4, indented paragraph 3, line 2, add "pay" after "monthly."

- 7. On page 5, paragraph 9, line 3, change "they" to "CalSTRS."
- 8. On page 5, paragraph 9, indented paragraph 2, lines 5-6, change "agreement and was not paid to the entire class of psychologists" to "agreement...and was not paid to the entire class of psychologists."
- 9. On page 6, paragraph 10, line 1, change "CRU determination" to "Decision Letter."
- 10. On page 6, paragraph 11, line 1, change "determination" to "Determination."
- 11. On page 7, paragraph 1, line 2, change "Board of Administration" to "Teachers' Retirement Board."
- 12. On page 7, paragraph 2, line 5, change "22201, subd. (a)" to "22250, subd. (b)."
- 13. On page 9, paragraph 7, line 4, change "22919.2" to "22119.2."
- 14. On page 9, paragraph 7, line 7, change "22919.2" to "22112.5."
- 15. On page 9, paragraph 7, line 9, change "after" to "beginning in."
- 16. On page 11, paragraph 12, line 3, change "6" to "5."
