




CHIEF INVESTMENT OFFICER REPORT

An understanding of global market performance in the current fiscal year and recent 3 year period is helpful context when reviewing semi-annual reports for each asset class. Since CalSTRS has a 30 year investment horizon it is helpful to look at these semi-annual snapshots over multiple time periods to get a sense of the changes over the past five to ten years.




U.S. Treasury Yield Curve




Asset Allocation


June 30, 2021 Asset Mix



During the July 2021 meeting, the Investment Committee adopted new interim asset allocation targets effective for July 1, 2021. The new targets include reductions in Public Equity and Fixed Income and increases in Private Equity, Inflation Sensitive and Risk Mitigating Strategies. The Investment Committee finished its last every-four-years Asset-Liability Management Study in 2019 when it adopted long-term asset allocation targets.








Non-U.S. Top 10 Net Exposure as of June 30, 2021




Non-U.S. Net Currency Value vs Total as of June 30, 2021

The law requires a subset of firms (~377) to register as "Lobbying Firms" if they intend to directly lobby specific Agencies, generally may focus on External Placement Agent firms. Below is a list of firms identifying themselves as "Lobbying Firms" that may or may not directly lobby CalSTRS. As such, Board and staff are subject to a \$10 per month gift limit with these firms. Staff has listed familiar firms to CalSTRS, but this may not be a comprehensive list of all Lobbying Firms that staff may encounter.
