In our letter dated October 25, 2021 (copy enclosed), the California State Teachers' Retirement System reported total creditable compensation earned and reported in fiscal year 2020-21 pursuant to Section 22955.5(b) of the Education Code in the amount of $\$ 34,893,100,710.38$.

We are submitting this letter pursuant to Section 22955.5(c) of the Education Code, which requires that on or before April 15 after submission of the report described above, the system notify the Director of Finance, the Chairperson of the Joint Legislative Budget Committee, and the Legislative Analyst of any revisions in its calculation of the total amount of creditable compensation for the fiscal year that ended on the immediately preceding June 30.
