



Pension Solution Overall Assessment



Overall Summary

The Interim Services Period (ISP) completed on 6/30/2023 and the project has begun to follow a formal schedule with an estimated go-live date in Fall 2025. Primary current activities include System Integration Testing (SIT), data-based project status tracking and reporting, and recruitment for a Project Manager.

Notable risks and mitigations

Risk: The Project Manager role currently remains vacant and is needed to drive coordination, standardization, and process adherence.


Accurate and complete project metrics and leading indicators are needed for accurate project status and schedule management.

Mitigation: CalSTRS expects to fill the Project Manager position with a qualified candidate by September 2023. Agreed upon metrics definitions, development standards, and reporting are currently being developed.

Progress Summary

Sagitec and CalSTRS are primarily focused on System Integration Testing (SIT) which is a collaborative effort to identify and resolve system defects prior to user acceptance testing. SIT is currently on schedule overall and meeting its objectives.


Notable Risks and Mitigations

Risk: If the testing execution and/or defect rate do not track to plan significant impacts to the schedule may be encountered.

Response: CalSTRS and Sagitec are developing standardized metrics to track and monitor SIT activities. Frequent regular meetings are held to discuss progress and address challenges.

Progress Summary

Project data is being captured, and progress metrics are being developed by Sagitec and CaISTRS. Standards for formally defining, presenting, and analyzing metrics are in discussion.


Notable risks and mitigations

Risk: Multiple sets of metrics maintained and reported by multiple entities may result in a lack of alignment on status and meaning

Mitigation: Metrics are being collected and developed by CaISTRS and Sagitec. Alignment is being reached on definitions and meanings of metrics based on multiple collaborative discussions.

Progress Summary

The project has continued recruitment and requisition efforts to fill key positions. The Project Manager role remains vacant and procurement activities for the Implementation Services vendor(s) is on track.

Notable risks and mitigations


Risk: The Project Manager role should be filled as soon as possible to drive standards and coordination across the project. Additional staff may be needed to support existing roles including Quality Management.

Mitigation: Project leadership roles continue to be filled and recruited for. An interim PM has been identified while recruiting continues.
