III. CONSIDERATION OF PROPOSED ADMINISTRATIVE DECISIONS (Item 3)

a. In the Matter of the Retirement Benefits of: Betty Forrester

The committee received a presentation from Ms. Kaur and Mr. Cozad regarding the proposed decision by the administrative law judge *In the Matter of the Retirement Benefits of: Betty Forrester*. The committee inquired about the origins of the case and how Ms. Forrester related to the audit conducted by CalSTRS in 2016. The committee also discussed how exactly Ms. Forrester's earnings were misreported due to her elected officer positions and whether Ms. Forrester's meetings with CalSTRS' benefits counselors prior to her retirement should have any bearing on the outcome of this matter.

Ms. Forrester expressed her disagreement with the proposed decision, relayed her struggle to get a hearing on the adjustments made to her retirement benefit, and claimed CalSTRS should have identified the errors with her benefit prior to her retirement. Ms. Forrester also detailed the harm this decision has done to her in her retirement and asked the committee to make an exception in her case by restoring her uncorrected monthly benefit amount.
