


CHIEF INVESTMENT OFFICER REPORT

An understanding of global market performance in the current fiscal year and recent 3 year period is helpful context when reviewing semi-annual reports for each asset class. Since CalSTRS has a 30 year investment horizon it is helpful to look at these semi-annual snapshots over multiple time periods to get a sense of the changes over the past five to ten years.











Asset Allocation






During the July 2022 meeting, the Investment Committee adopted new interim asset allocation targets effective for July 1, 2022. The new targets include a reduction in Public Equity and an increase in Real Estate and Inflation Sensitive. The Investment Committee finished its last every-four-years Asset-Liability Management Study in 2019 when it adopted long-term asset allocation targets. The next Asset-Liability Management Study will begin in November 2022.







Non-U.S. Top 10 Net Exposure as of June 30, 2022




