


CHIEF INVESTMENT OFFICER REPORT

An understanding of global market performance in the current fiscal year and recent 3 year period is helpful context when reviewing semi-annual reports for each asset class. 


U.S. Treasury Yield Curve







Asset Allocation

During the July 2023 meeting, the Investment Committee adopted new interim asset allocation targets effective July 1, 2023. The new targets include a reduction in Public Equity and an increase in Private Equity. The Investment Committee finished its every-four-years Asset-Liability Management Study this year when it adopted long-term asset allocation targets.








Non-U.S. Top 10 Net Exposure as of June 30, 2023




Non-U.S. Net Currency Value vs Total as of June 30, 2023

Internal Marketing Firms*

These are internal marketing staff that registered as a lobbyist with the Secretary of State. Lobbyists are prohibited from making or giving a gift of more than \$10 a calendar month and are required to report any gifts.

California Government Code Section 7513.85 and CalSTRS Board Policy Manual Section 600 J require disclosure of placement agent relationships and payments. The law requires many internal marketing staff to register as lobbyists and to fill out the CalSTRS Form 600 J. Below is a listing of the firms and their internal marketing staff that has complied with the CalSTRS filing requirements and has active investments. The law requires a subset of firms (~377) to register as "Lobbying Firms" if they intend to directly lobby specific Agencies, generally may focus on External Placement Agent firms. Below is a list of firms identifying themselves as "Lobbying Firms" that may or may not directly lobby CalSTRS. As such, Board and staff are subject to a \$10 per month gift limit with these firms. Staff has listed familiar firms to CalSTRS, but this may not be a comprehensive list of all Lobbying Firms that staff may encounter.
