IV. ANNUAL MEMBER SURVEY (Item 4)

The committee received a presentation from Mr. Buffalo covering the results of the 2022 Member Survey and learned that overall satisfaction with CalSTRS remained stable, with older respondents reporting higher levels of satisfaction and engagement than younger respondents. The committee received information about the factors driving overall satisfaction and trust with CalSTRS, as well as information about the Net Promoter Score. The committee learned about new measures added to the survey in 2022 relating to the effort required by members to reach a customer service representative, receive a resolution to their concern or question, and navigate the service retirement process. > The committee inquired about member confidence in living comfortably with their CalSTRS retirement benefit and learned from Ms. Lichnock about efforts to connect with retired members. The committee discussed member engagement trends and heard from Mr. Perez about ongoing efforts to engage members throughout their careers. The committee heard from Mr. Goldberg, who recommended methods to increase the survey population and indicated his intent to participate in future member workshops.

V. <u>SUBROGATION CLAIMS OVERVIEW (Item 5)</u>

The committee received a presentation from Mr. Chima and Ms. Minoya providing an overview of the CalSTRS subrogation process for Disability and Survivor Benefits. The committee received information about the legal basis for subrogation recovery and the various methods by which a claim may be identified. The committee learned about the assessment and processing of a subrogation claim, as well as recoveries in the last five calendar years, totaling approximately \$1.7 million for 19 case referrals. The committee engaged in a discussion about member notification and involvement in the subrogation process.
