

ACTIVITY UPDATE


January 1 to June 30, 2021

- Implemented new internally and externally managed portfolios that are benchmarked to the MSCI EM ESG Focus index.

REGIONAL EXPOSURE VS. POLICY BENCHMARK




INTERNAL VS. EXTERNAL MANAGEMENT




NET PERFORMANCE

January 1 to June 30, 2021


